How do we define death?

Key Theological Points

- Although death is normal, it is <u>not</u> natural
- Death is consistently personified in Scripture as "the enemy"
- Death has been conquered by Christ
- The "taking of life" is prohibited, except where expressly sanctioned.

Some conclusions

- We do not need to fear death because it has been conquered in Christ's death and resurrection.
- We must recognize, however, the theological implications of death, and take very seriously the Biblical concept of the imago dei.
- The world, in its confused depravity, takes the position that "if you can't beat 'em, join 'em" with respect to death and mortality.
- The church is neither "beaten" by death, nor allied with death, because Christ has conquered death.
